

LICENSE AGREEMENT

IMPORTANT READ CAREFULLY: BY DOWNLOADING, INSTALLING, AND/OR USING THE SOFTWARE (DEFINED BELOW), SUBSCRIBER/END USER AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, YOU MUST NOT DOWNLOAD, INSTALL, OR USE THE SOFTWARE, AND YOU MUST DELETE OR RETURN THE UNUSED SOFTWARE.

This License Agreement ("the Agreement") is a contract between LOGSIGN ("[LOGSIGN]") and ("CLIENT") an individual or entity and its Affiliates (defined below) regarding the use of LOGSIGN's software further described at (the "Licensed Software").

1. **DEFINITIONS**

- 1. "Affiliate" of a Party shall mean any entity that controls, is controlled by, or is under common control with such Party.
- 2. "Computer" means the hardware, if the hardware is a single computer system, whether physical or virtual, or means the computer system with which the hardware operates, if the hardware is a computer system component.
- 3. "Documentation" means the user documentation provided by LOGSIGN to SUBSCRIBER on the use of the Software.

"Software" means the object code versions of the product, together with the updates, new releases or versions, modifications, or enhancements, owned and provided by LOGSIGN to SUBSCRIBER pursuant to this Agreement.

2. GRANT OF LICENSE

Upon payment of the applicable fees for the Software and continuous compliance with the terms and conditions of this Agreement, LOGSIGN hereby grants to CLIENT a non-exclusive, limited, revocable, license to use the Licensed Software. Client agrees to use best endeavors to prevent and protect the contents of the Software and Documentation from unauthorized use or disclosure. LOGSIGN reserves for itself all other rights and interest not explicitly granted under this agreement

3. TRIAL, EVALUATION, AND BETA

If this Agreement is for a trial, evaluation, or beta license, the licenses granted herein will terminate upon the expiration or cancellation of the trial, beta, or evaluation period or when the Services are no longer available.

4. RESTRICTED USES

- 1. USE OF SOFTWARE: Client may not: (i) provide, make available to, or permit other individuals to use the Software or Documentation, except under the terms listed above, either in whole or part; (ii) modify, translate, reverse engineer, decompile, disassemble, create derivative works, or otherwise attempt to derive the source code based upon the Software or Documentation; (iii) copy, reproduce, republish, upload, post, or transmit the Software or Documentation; (iv) license, sell, rent, lease, transfer, sublicense, distribute, or otherwise transfer rights to the Software or Documentation; (v) remove any proprietary notices or labels on the Software or Documentation; or (vi) license the Software if to a direct competitor for the purposes of monitoring the Software's availability, performance, or functionality or for any other benchmarking or competitive purposes. Any such forbidden use shall immediately terminate subscriber's license to the Software.
- 5. **TRADEMARKS:** Client may not delete, remove, hide, move, or alter any trademark, logo, icon, image, or text that represents LOGSIGN name or any icon, image, or text that is likely to be confused with the same.
- 6. **RIGHTS RESERVED:** THE SOFTWARE IS LICENSED, NOT SOLD. This Agreement does not grant subscriber any rights, title, or interest in or to Software, Documentation, trademarks, service marks, or trade secrets, or corresponding Intellectual Property (including without limitation any

images, photographs, animations, video, audio, music, and text incorporated into the Software, the accompanying printed materials, and any copies of the Software), and all rights, title, and interest in and to the Software, Documentation, and corresponding Intellectual Property shall remain the property of LOGSIGN, its suppliers, or are publicly available. All rights not expressly granted under this Agreement are reserved by LOGSIGN. All title, rights, and interest in and to content, which may be accessed through the Software, is the property of the respective owner and may be protected by applicable Intellectual property laws and treaties. This Agreement gives Clients no rights to such content, including use of the same. To the extent the Software is bundled with third party software programs; these third-party software programs are governed by their own license terms, which may include open source or free software licenses. Nothing in this Agreement limits an end user's rights under, or grants the end user rights that supersede, the terms of any such third-party software.

7. UPDATES:

CLIENT may choose to use any updates or upgrades (collectively, "Updates") LOGSIGN provides to the Licensed Software, but only if they have a license to use the previous version of the Licensed Software. Unless LOGSIGN provides other terms in writing, CLIENT's installation and use of any update will be subject to this agreement. If SUBSCRIBER chooses to use an Update, LOGSIGN may charge CLIENT for the use and installation of that Update. CLIENT may continue to use the previous versions of the Licensed Software subject to the terms of this agreement, provided that the Update and the previous version are installed on the same computers. LOGSIGN will have no obligations to support previous versions of the Licensed Software.

The Software may require you to take certain steps to activate your Software or validate your subscription. Failure to activate or register the Software, validate the subscription, or a determination by us of fraudulent or unauthorized use of the Software may result in reduced functionality, inoperability of the Software, or a termination or suspension of the subscription.

8. NO WARRANTY

- 1. "As-Is". The [Licensed] Software is provided "as is," with all faults, defects, bugs, and errors.
- 2. No Warranty. Unless otherwise listed in this agreement, LOGSIGN does not make any warranty regarding the [Licensed] Software, which includes that SUB-LICENSOR disclaims to the [fullest] extent authorized by Law any and all [other] warranties, whether express or implied, including any implied warranties of [title, non-infringement, quiet enjoyment, integration,] merchantability or fitness for a particular purpose.
- 3. LOGSIGN disclaims to the [fullest] extent authorized by Law any and all [other] warranties, whether express or implied, including any implied warranties of [title, non-infringement, quiet enjoyment, integration,] merchantability or fitness for a particular purpose.

9. NON-INFRINGEMENT

The [Licensed Goods / Licensed Software / Licensed Method] does not infringe the Intellectual Property rights or other rights of any third party. The [Licensed Goods / Licensed Software / Licensed Method] is not in the public domain.

10. THIRD PARTY SOFTWARE

CLIENT hereby acknowledges that the Licensed Software might contain third party software that require additional notices or are subject to additional terms and conditions. If LOGSIGN does include third party software in the Licensed Software, LOGSIGN shall post any additional the notices and terms and conditions on LOGSIGN's website at [URL], and those terms and conditions are hereby incorporated into this agreement. If there are any conflicts between this

agreement and the additional terms or conditions governing third party software, those additional terms and conditions will control in connection with third party software.

11. CLIENT DATA

LOGSIGN may collect and use technical information gathered as part of its maintenance, support, and training services, only for the purpose of improving its products and services. LOGSIGN will not disclose this any of this information in a form that personally identifies CLIENTS.

12. CONFIDENTIALITY

Confidential Information" means all material, non-public, business-related information, written or oral, whether or not it is marked as confidential, that is disclosed or made available to the recipient, directly or indirectly, through any means of communication or observation by the disclosing party or any of its affiliates or representatives. The receiving party shall hold in confidence all Confidential Information in perpetuity, disclosed by the disclosing party to the receiving party. A receiving party may only use the Confidential Information according to the terms of this agreement [and solely for the Purpose]. The receiving party may not copy, record, or otherwise reproduce the Confidential Information without the disclosing party's written consent. LOGSIGN has no obligation, but reserves the right, to monitor and review client account information and history and the content and materials uploaded by you or others in the Software for the purpose of determining compliance with this Agreement or to detect illegal activity.

- 13. LIMITATION OF LIABILITY: TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL LOGSIGN, ITS DIRECTORS, OFFICERS, AGENTS, SUPPLIERS AND LICENSORS, BE LIABLE TO YOU (WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE) (I) FOR MORE THAN THE AMOUNT OF LICENSE FEES THAT YOU HAVE PAID TO LOGSIGN IN THE PRECEDING (12) TWELVE MONTHS FOR THE APPLICABLE SOFTWARE OR (II) FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, PUNITIVE, OR EXEMPLARY DAMAGES, INCLUDING WITHOUT LIMITATION LOST PROFITS, LOST BUSINESS OPPORTUNITIES, LOSS OF USE OF THE SERVICE OFFERING, LOSS OF GOODWILL, BUSINESS INTERRUPTION, LOSS OF DATA, LOST SAVINGS, OR OTHER ECONOMIC DAMAGE, ARISING OUT OF THIS AGREEMENT OR THE USE OR INABILITY TO USE THE SOFTWARE OR DOCUMENTATION, EVEN IF LOGSIGN HAD BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 14. **COMPLIANCE WITH APPLICABLE LAWS.** Subscriber agrees that subscriber shall use the Software and Documentation solely in a manner that complies with all applicable laws in the jurisdictions in which subscriber use the Software and Documentation, including, but not limited to, applicable restrictions concerning copyright and other Intellectual Property rights.
- 15. **CHOICE OF LAW AND VENUE.** This Agreement shall be governed by the laws of Switzerland except that the United Nations Convention on the International Sale of Goods shall not apply. Parties accept sole jurisdiction of the courts of Amsterdam.
